Final 50% FMV balance due the earlier of: 1) Within five (5) business days after the Dept. of Liquor notifies the applicant that the license is ready for issuance. 2) The first business day 180 days after the initial 50% deposit payment was due. 3) In either case, without exception, failure to submit the payment will result in an automatic forfeiture of the right to apply for the license and any previously paid fees. Final date for entrants to establish a location and submit applications and fees (36 months after the random selection drawing)	Monday, August 29, 2022

Lottery notes regarding local governing bodies:

- local governments must post lottery entry applications for 20 days.
- local governments have 60-days to submit recommendation regarding lottery applicants to DLLC.
- when DLLC receives a local government recommendation, a 15-day waiting period must pass prior to DLLC issuing the license.
