**Lottery notes regarding local governing bodies:**

- Local governments must post lottery entry applications for 20 days.
- Local governments have 60 days to submit recommendations regarding lottery applicants to DLLC.
- When DLLC receives a local government recommendation, a 15 day waiting period must pass prior to DLLC issuing the license.
